picked up bid packets for the construction component of this project, only 2 bids were received. The bids
ranged from \$574,426 (from ELQ Industries) to \$668,000 (from Coppola Paving & Landscaping Corp.).
ELQ Industries came in as the low bidder, with an estimated total construction cost of \$574,426. Hazen &
Sawyer performed an evaluation of the proposals and recommended that WJWW award the contract to
ELQ Industries. The Business Director reminded the Board that the Rye Lake Turbidity Curtain project
was previously approved with an overall project cost of \$900,000 (inclusive of engineering and
contracting work). Trustee Dionisio made a motion to award the construction bid to ELQ Industries in the
estimated amount of \$574,426. Trustee Torres seconded the motion, all in favor:
