- Advanced Metering Infrastructure (AMI) Project Update:
 - The Manager reported that WJWW had a conference call with NYCDEP to discuss the Water Demand Management Plan.
 - Reviewed with the Board the document received from NYCDEP staff on the Demand Management Plan budget.
 - The Manager reported on the new piece of equipment that will assist WJWW in finding service line breaks. NYCDEP will help with the cost of making repairs as part of the Demand Management Plan.
 - AMI program costs are approximately \$2.1 M, NYCDEP is expected to fund approximately 85% or \$1.8 M.
 - A conference call with NYCDEP is to be scheduled for early April to further discuss the program.
