### **Approval of Minutes**

#### **Financial Reports and Approvals**

Paving Projects increasing total project estimate by \$150,000 to \$300,000 due to higher than
anticipated component replacements.

Amendment of local capital project for VOM: Replacement of water main on Toni Lane/Sylvan Lane
increasing total project estimate by \$200,000 to \$400,000 due to broadened scope of project as a result
of extension of planned excavation due to existing main material; complications presented by other
utility infrastructure in the area; need to add fire hydrant and related connection; need to extend
service connections; and more extensive repaving;

 Approval of local capital project for the VOM: Replacement of Barry Avenue Bridge water main estimated at \$100,000. Water main is located on a Metro North bridge and is in poor condition. It is currently leaking and presents a potential hazard due to its location above the railway.

Trustee Rosenblum made a motion to approve the project. Trustee Belmont seconded the motion, all in favor:

The Business Director presented the current listing of overdue customer accounts.

The Business Director distributed copies of the WJWW's 2014 audited financial statements and reviewed the yearend financial position. He also discussed the 2015 budget relative to the 2014 results. The Business Director then reviewed cash flow timing impacts related to capital project disbursements and reimbursement of funds from the members. Further discussion on the financial results and budget deferred to future meetings.

### **Operations Status Reports**

The Business Director reported on the following regarding various WJWW operational items:

a. The year-to-date water production through the end of March 2015 was 980 million gallons compared to 947 million gallons through the end of March 2014 (an increase of 3.5%).

- b. Water Main Repairs and Facilities Improvements:
  - VOM
    - Repaired 2 inch water main break on Howard Ave.
    - Repaired service connection leak on Hill St.
    - Water main replacement work continuing near intersection of Mamaroneck Ave. and Boston Post Rd.
  - TOH
    - Repaired service connection leak on Glendale Rd.
- c. Storage Tank Rehabilitation/Repairs:
  - Park Lane #1: The exterior paint work is progressing and expected to be completed by mid-May, contractor payments pending.
  - Woodside Tank: Manager has signed the contract and work is expected to begin late Summer/early Fall.
- d. Meter Reading and Billing Status:
  - Meter reading for VOM (4,000 +/-) is scheduled to begin May 1st.
  - Seasonal turn-ons of irrigation systems are in progress.
- e. Improvements to Pump Stations:
  - Kenilworth Pump Station:
    - Objective is to maximize the use of Shaft 22 UV water.
    - Engineering work is moving forward.
  - Larchmont-Weaver Street Pump Station Upgrade:
    - Objective is to move Shaft 22 UV water to Kenilworth Pump Station. Manager to reach out to Larchmont to discuss this project.
    - Engineering work is moving forward.
  - Modelling evaluation indicates the need for a 16" diameter line between Mamaroneck Ave. and Macy Rd. (9,000 ft.) to maximize the use of Shaft 22 UV water.
- f. Hydrant Flushing
  - Completed on April 25<sup>th</sup>.
  - Minimal customer issues related to discolored water and runoff.
- g. Business Director added additional item to the agenda to be approved H2M proposal for asbestos water main technical services for a lump sum amount of \$1,700.

## **UV Alternative Status to Rye Lake Source**

- a. Finalizing a response to NYSDOH's "endorsement" letter which was received on April 2, 2015.
- b. Staying in close contact with WCDOH regarding the Basis of Design Report submittals. Kenilworth Pump Station Basis of Design Report was submitted on March 26<sup>th</sup> and the Larchmont Weaver Street Pump Station Basis of Design Reports is expected to be submitted early to mid-May.
- c. WJWW is finalizing it's Demand Management Plan with NYCDEP. A meeting was held on March 31st.
- d. In the process of coordinating with United Water for the seasonal operational adjustments.
- e. Scheduling discussions with the Town of Greenurgh and their engineering consultant regarding opportunities for shared facilities that would involve:
  - Use of a Delaware Aqueduct Shaft 20 pump station.
  - Catskill Aqueduct pump station.
  - A pipeline between these two pump stations.
- f. Scheduling discussions with White Plains regarding emergency interconnections at 2-3 potential locations (Mamaroneck Ave., North St. and Orchard St.)
- g. Planning to initiate SEQR procedures for the Shaft 20 projects.
- h. Preparing an internal plan for utilizing available sources for funding assistance such as grants and revolving loans.
