#### **Financial Reports and Approvals**

Op. explained that there was a significant leak at Carriage House Lane and Old White Plains Road that required substantial road restoration after the repair was made. There were also lead service lines that were replaced.

Trustee Murphy asked about bidding out jobs. The Manager/Business Director reported that emergency repairs and high-priority work with relatively short lead times are completed by WJWW's contractor under the terms of the Emergency/Priority Services Contract. Longer range planned improvements are bid out separately.

# **Old Business**

The Manager reported on the following:

- Flagler Drive Project Update:
  - Revised plans will be submitted to WCDOH for approval by the end of the week.
  - WCDOH approval is expected by the end of January.
  - High priority work related to installation of replacement water main in causeway section to begin as soon as possible.
- Bay Head as-builts have been submitted to WCDOH for approval.
- Macy Road Project Update:
  - Water main installation work is scheduled to begin shortly.
  - Notifications to be sent to residents regarding work schedules and traffic pattern changes (signage is being installed by contractor)
- Advanced Metering Infrastructure (AMI) Project Update:
  - WJWW staff met with representatives from Sensus today to discuss their AMI system. Sensus to provide formal proposal by mid-January.
  - WJWW has scheduled a meeting with Neptune to discuss their AMI system.
  - WJWW to meet with NYCDEP to discuss potential reimbursement of WJWW costs related to AMI system as part of its water demand management program.
- Westchester County Airport Future Water Needs and Facility Siting Update:
  - Manager to meet with Peter Scherer of Westchester County Airport to discuss airport's water needs and infrastructure and potential siting of WJWW water treatment facility.

# Manager's Report

- In order for the new N. Barry Ave.-Macy Rd. 16" Water Transmission Main to be fully effective, WJWW will need to install a 16" PRV at Purchase St, N. Barry and 1625 Mamaroneck Ave.
- Potential Alternatives to the Shaft 20 Project:
  - HDR is preparing an engineering proposal to assess a connection at the base of the Kensico Dam and a transmission main running from that point to the Purchase Tanks.
  - Hazen and Sawyer is preparing an engineering proposal to assess the construction of a filtration plant.
