Financial Reports and Approvals

The Business Director reviewed the bank balances and claims with the Board members. The Business Director asked if there were any questions on the claims:

Trustee Murphy asked how often NYC bills WJWW for water and the Business Director advised that we are billed monthly, however bills are sometime delayed.

Trustee Seligson asked about the 805 Mamaroneck Ave. – water main extension capital project and the Business Director reported that the owners of 805 Mamaroneck Ave. are paying 50% of the costs for the project.

Old Business

The Manager reported on the following:

- Flagler Drive Project Update:
 - Revised plans have been submitted to WCDOH for approval.
 - WCDOH approval is expected by the end of January.
 - Expect to break ground next month.
 - ELQ is performing the causeway work which should be completed before Summer (April/May).
 - The remainder of the project will be put out to bid.

Trustee Murphy requested that the Manager send an email explaining the need for the water main replacement at Bay Head. Guy Parisi will also explain why this project is a Type II SEQR Action.

- Macy Road Project Update:
 - Water main installation work will begin in VOM tonight.
 - Notifications have been sent to residents in VOM regarding work schedules and traffic pattern changes (signage is being installed by contractor).
- Advanced Metering Infrastructure (AMI) Project Update:
 - WJWW staff met with representatives from Neptune to discuss their AMI system. WJWW has requested Neptune provide a formal proposal.
 - Greenburgh, Larchmont and Scarsdale Water Depts. and Suez all use Neptune. Yorktown uses Sensus.
 - WJWW water meters are compatible with Neptune radio transmitters. So if we decide to use the Neptune program, approximately 14,000 Neptune transmitters will need to be installed instead of the 9,000 with Sensus.
 - Transmitters work on lithium battery and last approximately 10-20 years.
 - Awaiting proposal from Sensus.
 - WJWW to meet with NYCDEP to discuss potential reimbursement of WJWW costs related to AMI system as part of its water demand management program.

• The Business Director reported that there were 20 frozen meters, 10 frozen pipes and 17 water main breaks (8 breaks within the last week) during this cold weather.

Manager's Report

- The Business Director reviewed the water production report with the Board.
- The Manager reported that he will discuss water storage at the next Board meeting.

New Business

• The Business Director reviewed the 2018 Water Distribution Systems Bid with the Board. After review and discussion, Trustee Murphy made a motion to accept the bids for 34 items as per the bid review sheet (attached). Trustee Belmont seconded the motion, all in favor:
