Financial Reports and Approvals

The Manager reviewed the operating budget and capital projects with the Board and he also presented the current listing of overdue customer accounts.

There was a discussion amongst Board members and WJWW staff regarding concerns relative to the amount of time being devoted to responding to inquiries requesting WJWW financial data, information and procedures as well as being asked to perform various other financial analysis.

Operations Status Reports

The Manager reported on the following various WJWW operational items:

- a. The year-to-date water production through the end of July 2015 was 2.903 billion gallons compared to 2.729 billion gallons through the end of July 2014 indicating a year-to-date increase of 6.4% over the same time period.
- b. Water Main Repairs and Facilities Improvements:
 - VOM
 - Repaired water main valve box at intersection of Plaza Ave. & Madison St.
 - Retapped and repaired leaking service connection on Wagner Ave.
 - Plugged abandoned service line connection on Center Ave.
 - Repaired 6 inch water main break at intersection of Hoyt Ave. & Fenimore Rd.
 - Meeting of WJWW staff, Flagler Dr. representatives and WJWW engineering consultant (by phone) has been scheduled for August 26th.

- Replaced 6 inch water main valve at intersection of Forest Ave. & Vine Rd. related to paving projects.
- Replaced lead service connection on Villa Rd. related to paving projects.
- Replaced two lead service connections on Vine Rd. related to paving projects.

- Repaired 6 inch water main valve at intersection of Dundee Rd. & Mohegan Rd. related to paving projects.

- c. Storage Tank Rehabilitation/Repairs:
 - Woodside Tank: A meeting is scheduled with GHD on September 1st to discuss progress.
 - Woodside Zone PRV at Old Lake St. the PRV vault has been ordered and the work is expected to be completed by early-September.

- d. Meter Reading and Billing Status:
 - Meter reading for VOM (4,000 +/-) began on August 3rd.
 - Billing of VOM (4,000 +/-) is expected to be completed mid-August.
 - WJWW is evaluating options for initiating a phased approach to instituting monthly meter reading and billing; possibly starting with the TOM in 2016.
- e. Improvements to Pump Stations:
 - Kenilworth Pump Station:
 - Engineering work is progressing.
 - A meeting was held on July 29th with TOH Planning and Building Departments. WJWW also had a site visit with Morgan Stanley to discuss the need for upgrading the pump station.
 - There is a need for additional scope of work due to the TOH Planning Board review/request for the development of a site plan application which will include a Public Hearing and Basis of Design Report that will need to be submitted to the Health department for approval. H2M submitted a proposal for the additional work. Trustee Rosenblum made a motion to approve the proposal submitted by H2M. Trustee Belmont seconded the motion, all in favor:

UV Alternative Status to Rye Lake Source

On July 7th after the meeting with NYCDEP, NYSDOH and WCDOH, WJWW conducted a tour for NYSDOH staff of the proposed UV alternative siting/routing for a new connection to the Delaware Shaft 20.

WJWW and HDR participated in a Grants webcast on July 15th on possible grant opportunities for the UV alternative.

NYSDOH has contacted WJWW's attorney to start the process of preparing a settlement agreement related to the WJWW's UV alternative plan in place of building a Rye Lake filter plant.
