- Kenilworth Tank Replacement
 - Due to expansion of scope and increased cost of materials, the estimated project cost has increased to \$4,250,000 from the engineer's initial estimate of \$2,500,000. Following review and discussion, Trustee Murphy made a motion to approve the increase in the project (A-1346) cost estimate to \$4,250,000. Trustee Seligson seconded the motion, all in favor:

- Initial bids related to the project opened on August 20, 2018 were previously rejected based upon the Engineer's recommendation. The project was subsequently re-bid with a modified structure and scope involving separate contracts for general construction (Contract G) and tank construction (Contract T).
- Kenilworth Tank Replacement project bids associated with general construction (Contract G) were received and opened on September 26, 2018. The apparent low bidder is ELQ Industries with a bid of \$772,104. WJWW's project engineers, H2M, have reviewed the submitted bids and recommend that ELQ Industries be awarded the contract. Following discussion, Trustee Seligson made a motion to award the general construction contract (Contract G) to ELQ Industries, Trustee Murphy seconded the motion, all in favor:

- Kenilworth Tank Replacement project bids associated with tank construction (Contract T) were received and opened on September 26, 2018. Following discussion, Trustee Murphy made a motion to award the tank construction contract (Contract T) to ELQ Industries, Trustee Seligson seconded the motion, all in favor:
