Manager's Report

• The Manager informed the Board of a recent denial by Suez Water Westchester of a request by WJWW to open an interconnection for purposes of getting supplementary water during a NYCDEP maintenance shutdown of WJWW's Shaft 22 source. Requests of this type have been approved in the past.

New Business

• The Business Director discussed VOM local capital project (A-1358) to replace approximately 1,440 linear feet of transite water main on Barrymore Lane in the Village of Mamaroneck, following a recent break on the main and in accordance with established protocol, at an estimated cost of \$900 thousand. Following review and discussion, Trustee Murphy made a motion to approve the project and Trustee Seligson seconded the motion, all in favor:
