• Rye Lake Filtration Plant:

- SEQR Update: Lori Lee Dickson, General Counsel, shared that WJWW consultants are still on track with their work related to the draft FEIS, which is expected to be presented for Board consideration this fall. Water quality infrastructure grant opportunities continue to be explored and monitored. WJWW is planning to submit applications in early September for the WIIA and IMG Grant Programs administered through the NYS Environmental Facilities Corporation (NYSEFC). The WJWW received a grant previously through the IMG program for its UV Facility.
- Project, System Maintenance and Operational Updates: Frank Arcara, General Superintendent, provided the following updates:
 - O Claflin Avenue (VOM): The work to replace a section of the water main has been completed at this location. ELQ will now be performing full-width paving of the road.
 - The WJWW crews performed 7 service line repairs and ELQ crews performed one hydrant replacement, as well as 3 service line renewals. The Operations Department took a total of 88 samples - all came back within normal ranges.
