- Rye Lake Filtration Plant:
  - SEQR Update: Trustee Murphy shared that the Board was presented with a resolution to adopt the SEQR Findings Statement for the Rye Lake Filtration Plant. The Findings Statement was provided for review by the Board following the adoption of the Final Environmental Impact Statement (FEIS) at the Board of Trustees meeting on September 28, 2022. Trustee Murphy read the resolution to Adopt the SEQR Findings Statement, which explained that the adoption of will complete the environmental review process. All documents will be uploaded to the filtration plant website at www.wjwwfiltration.org, as required by SEQR regulations. Valerie Monastra, Principal Planner with Nelson Pope and Voorhis, who prepared the Findings Statement, was in attendance (virtually) to answer any questions that the Board may have had; there were no questions. #### **New Business**

• Approval of a Wasp Engineering proposal for the Remediation of the WJWW Maintenance Garage: David Birdsall, the Business Director, shared that remediation work to one bay (or side) of the WJWW maintenance garage is recommended due to the detection of asbestos wrapped pipes and lead paint, which can be seen peeling off the walls. It was emphasized that these conditions and the repair work being proposed are separate from and unrelated to the damage caused by Hurricane Ida. The Wasp Engineering proposal being offered for consideration by the Board, in the amount of \$131,840, is inclusive of all engineering oversite/inspection costs and construction costs, including each contractors' respective costs (remediation of asbestos and lead paint, air monitoring, wall patching and railing work). The work is expected to take approximately one month. Trustee Elkind Eney made a motion to approve the Wasp Engineering proposal for the Remediation of one bay of the WJWW Maintenance Garage, with a cost of \$131,840. Trustee Dionisio seconded the motion, all in favor:
