  - Lakeside Drive (TOM) Water Main Replacement: Frank Arcara, General Superintendent, shared that WJWW resubmitted an application to the Westchester County Department of Health three weeks ago, and that they have indicated they will be reviewing the resubmitted application early next week.
  - o Fire Department Hydrant Use Notification: Trustee Elkind Eney inquired as to what, if any, steps the Fire Department should take about notifying WJWW when they use a fire hydrant. Frank Arcara, General Superintendent, explained that the Fire Department should call the WJWW Distribution emergency number in advance at (914) 424-4371, to inform the on-call staff member that they are operating a hydrant. Hydrant use notification will help WJWW identify a potential source for brown water complaints should we receive calls from the public.
