The meeting was called to order at 4:13 p.m. with the following members present:

Approval of Minutes

Financial Reports and Approvals

The Manager reviewed with the Board the current bank balances and claims to be approved. After review, Trustee Belmont made a motion to approve the 82 claims in the amount of \$1,095,398. Trustee Seligson seconded the motion, all in favor:

The Manager reviewed the operating budget and capital projects with the Board.

The Manager presented the current listing of overdue customer accounts.

Operations Status Reports

The Manager reported on the following regarding various WJWW operational items:

a. The year-to-date water production through the end of April 2015 was 1.354 billion gallons compared to 1.291 billion gallons through the end of April 2014 (an increase of 4.8%).

b. Water Main Repairs and Facilities Improvements:

- TOM
 - Replaced 6 inch water main valve on Sackett Dr.
 - Repaired service connection leak on Clover Rd.
 - Repaired service connection leak on N Chatsworth Av.
- TOH
 - Repaired service connection leak on Hyatt Av.
 - Made new tap on Broadway.
 - Installed new tap & service line connection on Irving Pl.
 - Repaired service connection leak on Sterling Rd.
- c. Storage Tank Rehabilitation/Repairs:
 - Park Lane #1: The exterior paint work is completed and requisite testing in progress. Tank expected to be back in service on or about May 20-22.
 - Woodside Tank: Manager has signed the contract and work is expected to begin late Summer/early Fall and a pre-construction meeting will be scheduled soon.
- d. Meter Reading and Billing Status:
 - Meter reading for VOM (4,000 +/-) expected to be completed mid-May.
 - Seasonal turn-ons of irrigation systems are completed.
 - Business Director reviewed with Board need to maintain relationship with E.J. Prescott (Sensus metering equipment distributor) during Sensus' transition to a new distributor in New York State.
 - Manager mentioned that WJWW will continue to pursue possible County level legislation regarding the need to certify irrigation contractors.
- e. Improvements to Pump Stations:
 - Kenilworth Pump Station:
 - Objective is to maximize the use of Shaft 22 UV water.
 - Engineering work is moving forward.
 - Larchmont-Weaver Street Pump Station Upgrade:
 - Objective is to move Shaft 22 UV water to Kenilworth Pump Station. Manager to reach out to Larchmont to discuss this project.
 - Engineering work is moving forward.
 - Manager discussed engineering work needed relative to the proposed new 16" diameter line between Mamaroneck Ave. and Macy Rd. (9,000 ft.) to maximize the use of Shaft 22 UV water and as a backup to Shaft 22 if it were to be out-of-service.

UV Alternative Status to Rye Lake Source

The Manager reported that:

- WJWW sent response to NYSDOH's "endorsement" letter on April 30th. All ten comments from NYSDOH were addressed in great detail.
- WJWW is staying in close contact with WCDOH regarding upcoming Basis of Design Report submittals. Kenilworth Pump Station Basis of Design Report was submitted on March 26th and the Larchmont Weaver Street Pump Station Basis of Design Reports is being prepared.
- WJWW is in the process of coordinating with United Water for the seasonal operational adjustments.
- WJWW is scheduling discussions with the Town of Greenurgh and their engineering consultant regarding opportunities for shared facilities that would involve:
 - Use of a Delaware Aqueduct Shaft 20 pump station.
 - Catskill Aqueduct pump station.
 - A pipeline between these two pump stations.
- WJWW is evaluating possible sources of funding assistance such as grants and revolving loans.
