Financial Reports and Approvals

The Manager reviewed with the Board the current bank balances and claims to be approved. After review, Trustee Rosenblum made a motion to approve the 170 claims in the amount of \$616,974. Trustee Belmont seconded the motion, all in favor:

The Manager informed the Board that he received a quote from Arthur J. Gallagher for WJWWs insurance renewal for the period November 2015 through October 2016. Operations Status Reports

The Manager reported on the following various WJWW operational items:

- a. The year-to-date water production through the end of September 2015 was 4.110 billion gallons compared to 3.790 billion gallons through the end of September 2014 indicating a year-to-date increase of 8.4% over the same time period.
- b. Water Main Repairs and Facilities Improvements:
 - VOM
 - Repaired 8 inch water main leak-required installation of 9 feet of ductile iron pipe, on Fairway Green.
 - Replacement of 900 feet of asbestos water main on Hommocks Rd continuing. Need to amend scope of local capital project to reflect 900 feet of replacement water main and related appurtenances. The total cost of the project is estimated at \$420,000.

After discussion, Trustee Seligson made a motion to amend the scope of this local capital project. Trustee Rosenblum seconded the motion, all in favor:

- Replacement of 500 feet of asbestos water main on Hommocks Rd continuing. Need to amend scope of local capital project to reflect 500 feet of replacement water main and related appurtenances. The total cost of the project is estimated at \$230,000.

- Plugged old water service connection on Library Lane.
- Installed hydrant & valve on Woodside Ave.

c. Storage Tank Rehabilitation/Repairs:

- Woodside Tank: WJWW met with GHD and NUCO to discuss mobilization and site preparation work and what steps are needed to move forward with the project..
- Woodside Zone PRV at Old Lake St. New PRV valve has been activated and is in service; awaiting the installation of the modified vault roof, electrical service and SCADA panel and controls.
- Flagler Drive: Engineering work progressing and discussions are scheduled regarding phasing of engineering and construction.
- Westchester Water Works Conference has selected the Park Lane #1 Tank Rehab. Project for an award as an outstanding project in the storage tank category. The award will be given to WJWW at the Annual Fall meeting which was rescheduled for October 26th.

d. Meter Reading and Billing Status:

- Meter reading for TOH (7,000 +/-) began October 1st.
- Meter billing for TOH (7,000 +/- is expected to be completed by mid-late October.

e. Improvements to Pump Stations:

- Kenilworth Pump Station:
 - Engineering work is progressing.
 - Project was presented to the Town of Harrison Planning Board on September 29, 2015. A Public Hearing is scheduled for October 28th.
 - This project may also need a zoning variance this matter is currently under discussion.
 - A proposal was received from Carlin Simpson & Associates for subsurface soil and foundation investigation. After discussion, Trustee Belmont made a motion to accept the proposal. Trustee Seligson seconded the motion, all in favor:

- Larchmont-Weaver Street Pump Station Upgrade:
 - Engineering work is progressing.

- a. WJWW's December 2014 Conceptual Design Plan is currently being reviewed and the detailed engineering work is underway.
- b. Kenilworth Pump Station upgrade project is nearing completion of design and construction documents including regulatory applications by H2M. They have been submitted to the Town of Harrison Planning Board and were presented on September 29, 2015.
- c. Weaver Street Pump Station upgrade detailed engineering work is progressing.
- d. New 16" Transmission Main (Mamaroneck Ave. to Macy Rd): Gannett Fleming has submitted a proposal for Task II Engineering Design. Trustee Rosenblum discussed the need for a secondary route for emergency vehicles and other existing issues. The Manager and Business Director will follow up with these concerns. After review and discussion, Trustee Seligson made a motion to approve the proposal. Trustee Rosenblum seconded the motion, all in favor:
