1. RECEIPT OF BIDS

The Westchester Joint Water Works (OWNER) will receive sealed Bids plainly marked, "Rye Lake Turbidity Curtain - Contract A-1320" addressed to Westchester Joint Water Works, 1625 Mamaroneck Avenue, Mamaroneck, New York, 10543 until 1:00 PM prevailing local time on August 22, 2017.

2. PROJECT

- d. Protection of existing structures.
- e. Site restoration to pre-existing conditions or better.

The Bid Security shall be in the form of a certified check or bank draft payable to the Westchester Joint Water Works, or a satisfactory Bid Bond executed by the Bidder and a Surety Company in the amount equal to five percent (5%) of the Bid and shall be submitted with each Bid.

All such Bid Security will be returned to the respective Bidders within fourteen (14) days after Bids are opened except those which the OWNER elects to hold until the Successful Bidder has executed the Contract. Thereafter, all remaining Bid Security, including the Bid Security of the Successful Bidder, will be returned within seven (7) days of Contract signing or ninety (90) days after the bid opening, whichever is less.
